RESOLUTION APPROVING ARTICLE 10 (1) ROSEVILLE VOLUNTEER FIRE RELIEF ASSOCIATION; GOVERNANCE AND ADMINISTRATION OF SENATE FILE 1398 APPROVED BY THE STATE LEGISLATURE ON MAY 20, 2015

- WHEREAS, on December 8, 2014, the Roseville City Council, by motion approved the Roseville Fire Relief Association to pursue special legislation to allow for retirees to sit on the board of the Roseville Fire Relief Association.
- WHEREAS, on May 20, 2015, the Minnesota State Legislature gave approval to SF 1398 that contained the desired changes of the Roseville Fire Relief Association and the City of Roseville in Article 10 (1) of the bill.
- WHEREAS, on May 22, 2015, Governor Mark Dayton signed the bill into law.
- WHEREAS, the City Council of Roseville has reviewed the law as approved by the state legislature and signed by the Governor.
- NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Roseville hereby approves the special law contained in Article 10 (1) of Senate File 1398 and subsequently signed into law by the Governor.
