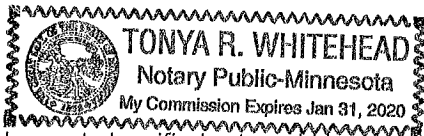

**AN ORDINANCE AMENDING
SELECTED TEXT OF THE
ROSEVILLE CITY CODE
TITLE 8, CHAPTER 801,
MUNICIPAL WATER SYSTEM**

The following is the official summary of Ordinance No. 1504 approved by the City Council of Roseville on July 11, 2016:

The Roseville City Code is hereby amended to modify/clarify specific requirements within Roseville City Code, Title 8, Chapter 801, Municipal Water System.
