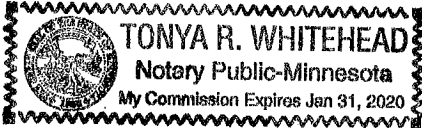

The following is the official summary of Ordinance No. 1520 approved by the City Council of Roseville on March 13, 2017:

An Ordinance amending §1009.07 of title 10 Zoning Ordinance and §1102.01.B of Title 11 Subdivision Ordinance, of the City Code, amended these sections and implementing a formalized policy regarding Developer Open House Meetings to be administered by the Community Development Department's Planning Division.
