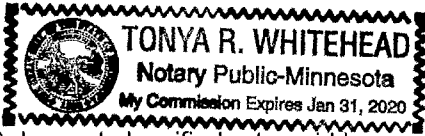

AN ORDINANCE AMENDING
SELECTED TEXT OF THE
ROSEVILLE CITY CODE,
SECTION 307.06: DURATION
THE CITY OF ROSEVILLE
ORDAINS:**

SECTION 1. Purpose: The Roseville City Code is hereby amended to modify/clarify specific requirements within the Roseville City Code, Section, 307.06: DURATION.

SECTION 2. Chapter 307 Section 307.06 is hereby amended as follows:

307.06: DURATION:
All Contractor Licenses issued under this Chapter are effective upon issuance and expire on ~~December 31 of the year one year (365 days)~~ from date of issuance.

SECTION 3 Effective Date. This ordinance amendment to the Roseville City Code shall take effect upon passage and publication.
