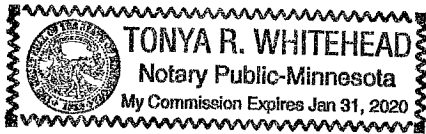

The Roseville City Code is hereby amended to modify/clarify specific requirements within Roseville City Code, chapter 404 Air Pollution Control.
