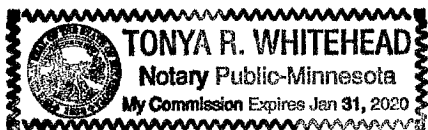

**AN ORDINANCE AMENDING
SELECTED TEXT OF THE
ROSEVILLE CITY CODE,
TITLE 9, CHAPTER 908, TO
REGULATE RENTAL LICENSING
FOR MULTIFAMILY RENTAL
DWELLINGS OF 5 OR MORE
UNITS**

The following is the official summary of Ordinance No. 1534 approved by the City Council of Roseville on October 23, 2017:

The Roseville City Code is hereby amended to modify/clarify specific requirements within Roseville City Code, Title 9, Chapter 908, to Regulate Rental Licensing for Multifamily Rental Dwellings of 5 or More Units.
