Pursuant to due call and notice thereof, a regular meeting of the Board of Commissioners (the "Board") of the Roseville Economic Development Authority ("REDA") was duly held on the 20th day of September, 2021, immediately preceding the meeting of the City Council of the City of Roseville.

RESOLUTION No. 96

RESOLUTION APPROVING COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM AGREEMENT BETWEEN THE ROSEVILLE ECONOMIC DEVELOPMENT AUTHORITY AND RAMSEY COUNTY HOUSING AND REDEVELOPMENT AUTHORITY

- WHEREAS, The Roseville Economic Development Authority, ("REDA") previously proposed to act on behalf of the City of Roseville (the "City") for the purpose of applying for grants to finance a portion of the costs of construction of the proposed Marion Street Greenway Connection (the "Public Infrastructure"), to be located at Marion Street and South McCarrons Boulevard in the City; and
- WHEREAS, REDA approved Community Development Block Grant Investment Partnership Program ("CDBG") funds allocated to Ramsey County Housing and Redevelopment Authority (the "County HRA") as a potential source of grant funding to finance a portion of the costs of the Public Infrastructure, and authorized REDA staff to apply for a CDBG grant (the "Grant") for such purpose; and
- WHEREAS, The County HRA having awarded the Grant to REDA, REDA and the County HRA now propose to enter into a Community Development Block Grant Program Agreement dated as of July 1, 2021 (the "Grant Agreement"), memorializing the terms and conditions of the receipt by REDA of the Grant; and

- WHEREAS, REDA's Board of Commissioners and legal counsel have reviewed the Grant Agreement and find that the approval and execution of the Grant Agreement are in the best interest of the City and its residents.
- NOW, THEREFORE, BE IT RESOLVED, that the Grant Agreement as presented to the Board is hereby in all respects approved, subject to modifications that do not alter the substance of the transaction and that are approved by the President and Executive Director, provided that execution of the Grant Agreement by such officials shall be conclusive evidence of approval.
- BE IT FURTHER RESOLVED that the President and Executive Director are hereby authorized to execute on behalf of REDA the Grant Agreement, and any other documents requiring execution by REDA in order to carry out the transaction described in the Grant Agreement.
- BE IT FURTHER RESOLVED that REDA staff and consultants are authorized to take any actions necessary to carry out the intent of this resolution.
