SITE: 1960 Twin Lakes Parkway

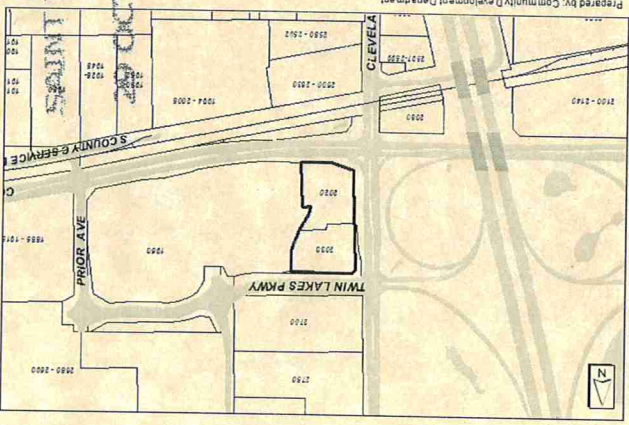
