RESOLUTION AUTHORIZING STAFF TO AMEND THE GUIDELINES FOR THE GREEN AWARD PROGRAM

- WHEREAS, the Roseville Economic Development Authority ("REDA") assumed administration of the Green Award Program that was developed by the Housing and Redevelopment Authority in and for the City of Roseville, Minnesota on January 4th, 2016; and
- WHEREAS, REDA now wishes to make certain changes to the Green Award Program to allow for business properties to be recognized in addition to residential properties.

NOW, THEREFORE, BE IT RESOLVED as follows:

- 1. The REDA Executive Director is hereby delegated to approve modifications to the Green Award Program as discussed and expressed at the meeting of the Board on this date hereof, provided that such modifications do not adversely affect the interests of the REDA and such modifications do not contravene or violate any policy of the REDA or any provision of law.
- 2. The REDA further approves any related documents necessary in connection with the modification of the Green Award to include businesses in addition to residential properties Program as contemplated by this resolution, including without limitation all amendments to documents and policies relating to the Green Award Program including

the program application, brochure and guidelines (collectively, the "Amended Program Documents") and hereby authorizes the Executive Director of REDA to prepare the Amended Program Documents on behalf of the REDA, and to carry out, on behalf of the REDA, the REDA's obligations thereunder when all conditions precedent thereto have been satisfied.

- 3. The approval hereby given to the Amended Program Documents includes approval of such additional details therein as may be necessary and appropriate to carry out the modification to the Green Award Program as discussed and expressed at the meeting of the Board and such modifications thereof, deletions therefrom and additions thereto as may be necessary and appropriate and approved by legal counsel to the REDA and by the Executive Director of the REDA; and said Executive Director is hereby authorized to approve said changes on behalf of the REDA.
- 4. The REDA hereby authorizes and directs the Executive Director and REDA staff undertake and implement the modification to Green Award Program and Amended Program Documents to carry out the modification to the Green Award Program as discussed and expressed at the meeting of the Board and take all actions necessary in connection therewith.
