RESOLUTION NO. 5

A RESOLUTION AUTHORIZING THE EXECUTION AND DELIVERY OF A CONTRACT FOR PRIVATE REDEVELOPMENT BY AND BETWEEN THE HOUSING AND REDEVELOPMENT AUTHORITY IN AND FOR THE CITY OF ROSEVILLE AND THE GREATER METROPOLITAN HOUSING CORPORATION OF THE TWIN CITIES

BE IT RESOLVED by the Board of Commissioners (the "Commissioners") of the Housing and Redevelopment Authority in and for the City of Roseville (the "Authority") as follows:

Section 1. Recitals.

- 1.01 The Authority has acquired or will soon acquire five single-family home sites (the "Property") in the Applewood Pointe development from United Properties Investments, LLC in order to further the Authority's goal of providing affordable workforce housing to first-time home buyers.
- 1.02 It has been proposed that the Authority enter into a Contract for Private Redevelopment (the "Contract") with The Greater Metropolitan Housing Corporation of the Twin Cities ("GMHC") for the construction and sale of new homes on the Property.

Section 2. <u>Findings.</u>

2.01. The Authority hereby finds that the Contract promotes the Authority's goals as set forth in its Housing Plan by assisting in the alleviation of a shortage of residential housing available within the City at prices affordable to first-time homebuyers.

2.02. The Authority hereby finds that preservation of the quality of life in the City is dependent upon the maintenance, provision and preservation of a variety of housing types, including affordable workforce housing, and that accomplishing this is a public purpose.

Section 3. Authorization.

3.01 The Executive Director and the Chairman of the Authority (the "Officers") are hereby authorized to execute and deliver a Contract when the following condition is met:

Substantial conformity of the Contract to the form of Contract presented to the Authority as of this date, with such additions and modifications as the Officers may deem desirable or necessary as evidenced by their execution of the Contract.

WHEREUPON said resolution was declared duly passed and adopted.
