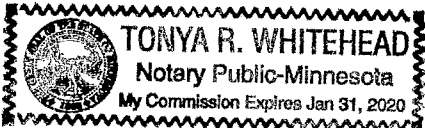

DESCRIPTION OF WORK: The work includes the construction of approximately:

Cedarholm Community Building - remove existing clubhouse facility; relocate, construct, or upgrade site utilities; construct community building; construct parking area; construct site improvements related to the community building; restore disturbed areas.

Cart Storage Building - Construct new cart storage building

Together with numerous related items of work, all in accordance with Plans and Specifications.
