a. PLANNING FILE 20-004

Request by KK Design for a variance from City Code Section §1005.4 "Neighborhood Business District", to allow a storage area addition that would encroach into the required side yard setback.

Senior Planner Lloyd reviewed the variance request for this property, as detailed in the staff report dated May 6, 2020.

Chair Sparby wondered how this is going to fit in with the locality there. He asked if this altered anything or does it fit in with the neighboring properties.

Mr. Lloyd thought it would be largely invisible. He reviewed the aerial with the Board and indicated the area is totally screened from the north and west and will not be seen by anyone passing on the street.

Chair Sparby invited the applicant to make a presentation and answer questions.

Mr. John Kosmas addressed the Variance Board. He indicated he was available for questions.
