Re: 2996 Center Pointe Drive - Master Sign Plan Approval

On May 10, 2012, the Roseville Master Sign Plan Committee held the administrative hearing to review and consider the Master Sign Plan 2996 Centre Pointe Drive. No adjacent property owners or citizens were present to address the committee and the City Planner did not receive any calls, email, or letters concerning the proposal.

The MSP Committee has reviewed the proposal and approves the following as the MSP for 2996 Centre Pointe Drive:

WALL SIGN REQUIREMENTS

- Advertising, flashing, pulsating, rotating light (or lights), rooftop, banners, mobile signs, and portable signs shall be prohibited, as well as other prohibited signs covered under Section 1010 of the Roseville City Code.
- The building front or main public entry has been determined to be 465 lineal feet for which 1.5 square feet of signage per lineal foot shall be applied for a total wall sign allowance of 698 sq. ft.
- Wall signs meeting the total square footage allowed, can be installed on all four sides of the building.
- Wall signs (including identity logos, corporate shields, insignias, crests, and/or symbols) shall be non-illuminated cast aluminum letters not exceed 24 inches in height.
- When applying for a sign permit, a spreadsheet shall accompany the permit providing information on existing sign, proposed sign, and remaining square footages.

OTHER REQUIREMENTS

- Landlord//owner sign-off of any sign proposal shall accompany any sign permit and shall meet the requirements of the MSP.
- A sign permit is required for the installation of all signs on the premises.

SIGN CRITERIA

GENERAL

- An area identification sign (Ground sign) will be provided for the site containing only project name.
- No pylon signs will be permitted.
- Signage on the building facade will be permitted for those tenancies located in those areas of the buildings designed for combined office-warehouse use.
- All signage permitted on the buildings shall be of the unlighted type.
- The furnishing and installation of signs as provided for herein and the costs incurred will be the responsibility of the tenant.
- It is intended that the signage for each combination office/warehouse use be uniform
 in design and style of lettering and although previous and current signage practices of
 the tenant will be considered, it will not be the governing factor in the approval of
 signs to be installed.
- Service doors at the rear or service areas of the building may be identified with professionally applied signs, identifying the business name and address of the tenant only. Lettering shall not be larger that 3" in height and shall be uniformly placed at each tenant location as approved by the owner landlord.
- Tenants shall not post any signs other than those provided for herein.

SIGN CRITERIA

- The wording of the signage provided for herein shall be limited to the tenants business identification (name) only and shall not include items sold or services provided. (The intent here being that of business identification and not product or service advertising).
- The use of corporate shields, logos, or insignias will be permitted (subject to Landlord's
 approval), provided such corporate shields, crests, logos, or insignias shall not exceed
 the allowable height for sign letter.
- Multiple or repetitive signage will be allowed only with the approval of the Landlord provided the area of such signage conforms to the limitations set forth herein.
- All signs and identifying marks shall be within the limitations of the sign facia as set forth on the accompanying building elevation drawings, Sheet No. A8.1 dated 31 May, 1993 - Exterior Elevations Building A.
- Internally lighted and/or flood lighted signage will not be approved.

SIGN CRITERIA

Attached is the Sign Criteria for Centre Pointe I. Because all signs require the Landlord's prior approval we ask that you or your sign contractor submit the sign drawing including dimensions and location on the building to Ryan Properties, Inc. and we will have it reviewed for the necessary approval. Also it will be necessary for your sign contractor to check with the City of Roseville on their signage regulations to assure compliance.

Upon written approval you may then proceed with your sign contractor.

SIGN CRITERIA, CON'T

- The following design standards will be adhered to:
 - 1. Cast aluminum letters with 90° corners, satin finish, $\frac{3}{4}$ " deep and stud mounted $\frac{1}{2}$ " from building face.
 - 2. Letters will be 12", 16", 18", or 24" in height.
 - 3. Letter bars or continuous sign backing will not be permitted.

PROHIBITED TYPES OF SIGNS OR SIGN COMPONENTS

- Moving or rotating signs.
- Illuminated signs.
- Signs employing moving or flashing lights.
- Signs employing exposed raceways.




